## WHAT WE DO

### Mission:

The North Central Florida Alliance for the Homeless and Hungry partners with the community to prevent and end homelessness and hunger, and to increase self sufficiency for individuals and families by providing leadership, advocacy, support, standards and funding.

### Vision:

To make homelessness rare, brief and non-recurring

### Background:

- The Alliance was formed in 1994 to serve its member agencies, and the homeless, as a clearinghouse for information and direction on service coordination, gaps analysis, advocacy and program development
- The Alliance members partner with the Lead Agency to create the Continuum of Care

### Responsibilities of the Lead Agency:

- Assist member organizations applying for and receiving federal and state grant funds
- In partnership with the Alliance members, develop the local homeless Continuum of Care plan for the homeless and those at risk of homelessness
- Coordinate the delivery of services and work with partners to assess gaps and fill needs

### Membership Levels:

- **Neighbor** - someone who is currently homeless and/or utilizing emergency services and/or formerly homeless

- **Advocate** - concerned and aware of the issues surrounding homelessness and will actively share them with others
- **Agency** - qualifying member organizations may receive assistance applying for federal and state grant funds, as well as technical assistance and training
