Homeless Continuum of Care - United Way NCFL, in its capacity as lead agency for the FL-508 homeless Continuum of Care (CoC), served as the collaborative applicant, fiscal agent, and administrator of funds awarded to the CoC through the Federal Department of Housing & Urban Development and Florida State Department of Children & Families. Funds were sub-granted to local nonprofits serving the homeless population through various programs such as rapid rehousing, transitional housing, homeless prevention and emergency shelter.

Community Impact - United Way North Central Florida serves as fiscal agent for the University of Florida's Campaign for Charities (UFCC). Funds raised through UFCC are primarily designated to local nonprofit agencies. United Way processes these donations and distributes them to the designated agencies on behalf of UFCC. United Way also distributes donations to nonprofits who have been designated a gift through any workplace payroll deduction campaign.

UWNCFL Programs - United Way North Central Florida operates a variety of programs benefiting the community. These programs include the 211 Helpline, ReadingPals, Volunteer Income Tax Assistance (VITA), Alachua County Campaign for Grade Level Reading, FEMA's Emergency Food & Shelter Program (EFSP), Disaster Relief & Recovery, and several assistance funds providing help with rent and utilities.
