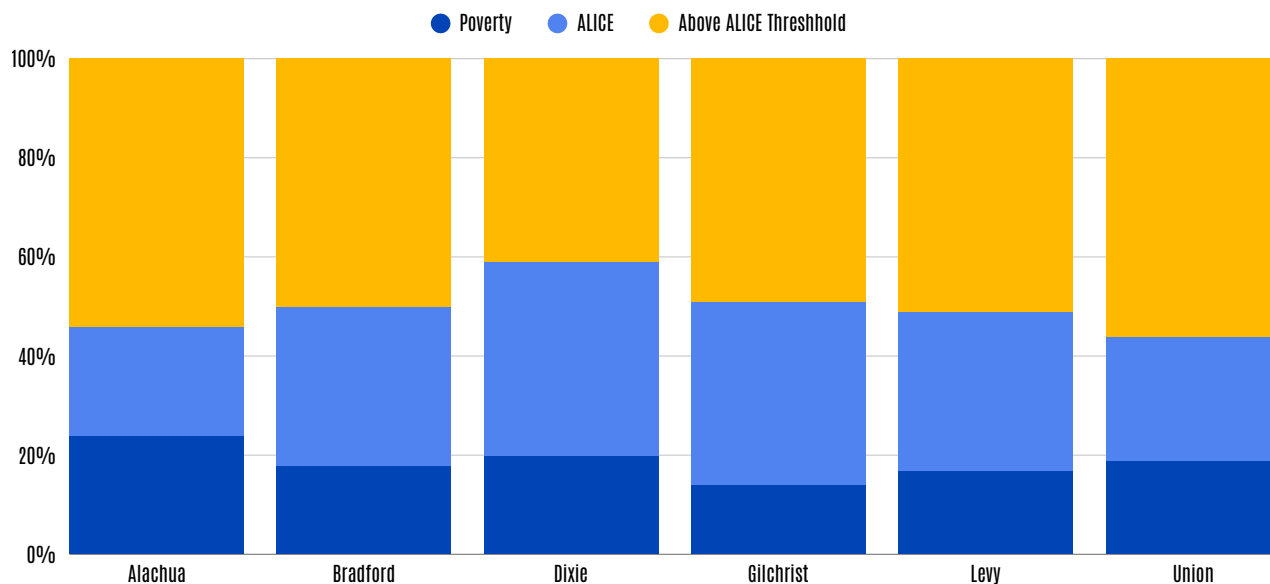
Why Sponsor or Donate to the Silent Auction

ALICE is Locked Out and Forced to Make Impossible Choices

Despite ALICE living paycheck to paycheck, in many cases ALICE earns too much to qualify for support leaving ALICE families ensnared in a constant battle to make ends meet. Pay my utility bill, or buy healthy food for my family? Pay for child care, or work reduced hours to stay home?



In 2024, a family of four in Alachua County needed **\$97,440** just to cover the essentials - over three times the Federal Poverty Level of **\$31,200**.
